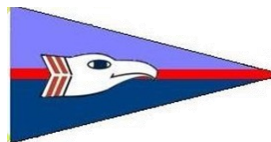


Spring is here and we are hoping for rain to put out the many Florida fires. With rain we are likely to also have lightning. Make sure that you pay attention to your local weather before and during your boating activities. If you hear thunder it is time to find shelter. Watch for dark clouds and wind direction. If caught in a heavy rain, canals are a good source of shelter and can help block winds. Make sure you have a plan as to what you will do if bad weather catches you on the water. During summer months it may be a good idea to plan shorter trips. Also, morning in general is more calm than afternoon weather. The important thing is that you get out and enjoy your boat. This can be done frequently with just a little preplanning. Check your local weather applications. I like intellicast weather on my computer www.intellicast.com and Storm weather on my phone, iphone.appstorm.net or on androids <https://www.wunderground.com/micro/storm>. NOAA weather also has weather information for boaters. Have you ever wondered what the Marco Island Beach was like, is the water calm or are there waves on the beach? You can easily find out by looking on line at the Marco Island Marriot web camera. With the waters warming it is a great time to take your boat to the beach, have a picnic and go swimming!



Since May is National Boating Safety Month take the time to teach a child how they can correctly put on a lifejacket by themselves or teach guests on your boat how to properly use a marine radio. It is our responsibility to educate our crew. Always, always have plenty of water on your boat! Remember emergencies are never planned. Also, check your First Aid kit maybe there is something you would like to add to it. (see page 11) Sandburs can be a problem in some beach areas, tweezers would come in handy!

The 4th of July is a great time to have family visit. We are planning a 2-hour free boating safety class for children 8 to 10 years of age. I would like to ask squadron members if they have children in town that would like to participate to please call me so I can coordinate a date for the class.

My motivation for taking MISPS classes was to assure that I had the skills, knowledge and experience to operate my vessel responsibly and safely. I wanted to own a boat, but didn't know a darn thing about how to operate one.

Educational program for the winter is not yet over. Test results for Piloting are due in for two students. Our Junior Navigation students will complete their tests by the end of May. Because of the increased interest in the America's Boating Course we scheduled an extra class in April and are offering a special ABC class to high school students in May. So far three members have signed up for Piloting over the summer. Also under consideration is a 2-hour seminar for third graders.



On to the future. Course schedule for the Fall and Winter will be finalized over the next few months. 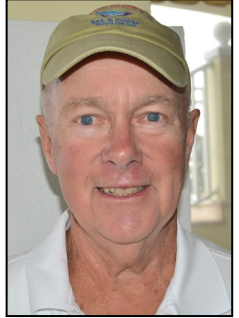

Man Overboard! The words no boater wants to hear.

Of course, as the circumstances differ so may the severity of the situation. Is the water cold, the current swift, or the wind strong? Is visibility poor? Are there others remaining on the boat to help? Is the swimmer injured?



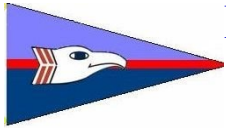
There are numerous ways a person may go overboard – a sudden, unexpected acceleration or deceleration or sharp turn; passengers unfamiliar with the boat or boating; excessive partying; various fishing scenarios; collision with another boat or object in the water; or sailing situations such as fixing a luffing sail, a jibe and swinging boom, or trying to repair troublesome gear.

How to avoid a MOB. First, make sure your passengers are familiar with your boat. Advise them of any major unanticipated changes in speed or direction. Minimize alcohol consumption. Avoid sitting on bow, stern or gunwales during boat operation.

Planning for a MOB. First and foremost, all on board should be wearing life jackets. A Coast Guard approved floatation cushion or ring must be readily accessible. Invest in a throw bag with poly line. Consider practicing a response and lifting a lifeless person onto your boat.

Responding to a MOB. The first person to see the man overboard should keep eyes on the person and point to location alerting others on the boat. If available, the captain can use the MOB function on the GPS. Throw either the floatation cushion or cleated throw line to the victim depending on the situation. Circle around the person with slowing speed, positioning the boat on the downwind side so that the boat is not blown into him. Take the motor out of gear. If necessary, a crew member, wearing a PFD and cleated line may have to go into the water to assist; it's always better to approach a drowning victim from behind. Depending on water conditions and injuries to the person, now might be the time to call on your radio for help or standby medical assistance. Law requires the boat operator to submit a casualty or accident report to the State reporting authority when, a person is injured and requires medical treatment beyond first aid 🚤

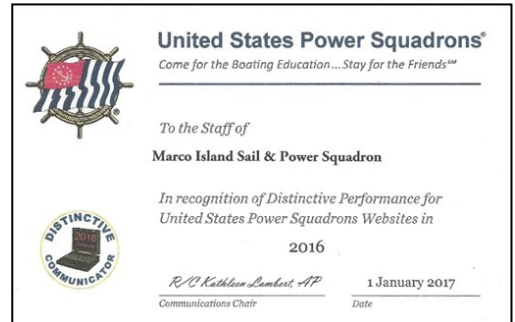

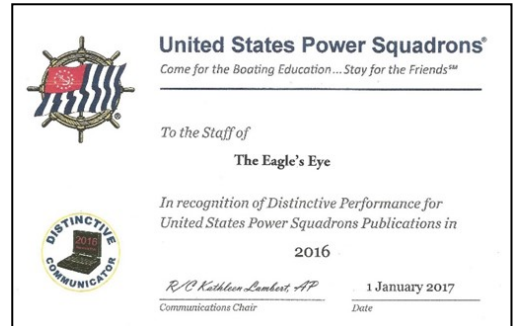

Blue Chip Boat Fire

Fire on board a boat is every mariner's nightmare. Far from shore, with no fire-fighting help available, and plenty of flammable fiberglass or wood, volatile fuel, and with nowhere to run except over the side, any fire can become a disaster in a hurry. If you have the slight doubt about whether you can contain the fire, don't even try.

- Your first concern is the safety of the people aboard.
- Notify someone immediately of your situation and location before the fire burns through the battery cables or forces you off the boat.
- Burning fiberglass is extremely hot and gives off noxious fumes. If fiberglass is burning. Get off immediately.

These words were written in 2010 when I was the Safety Officer of the Marco Island Squadron. After 45 years of boating and many thousands of cruising miles, this was my first experience with fire. I tried to do the simple things learned from squadron education and hoped for the best.

We were 6 hours into a 7-hour delivery cruise from a boat yard on the Manatee River when suddenly, there was heavy smoke coming from the enclosed engine room and rolling into the forward cabin and bridge deck. The engine RPM dropped from cruising to a fast idle. I immediately put the engine in neutral and turned it off. I was concerned that the fiberglass might catch on fire and we would have to leave the boat and jump into the Gulf. My wife, Marji, dove into the smoke-filled cabin and grabbed our Class 1 Life Preservers. We were offshore about 2 to 3 miles (for a couple in their late eighties, it might as well have been 200 miles). There was sufficient smoke on the 'bridge deck' to give me concern about exposure, but I did manage to shut off the master electrical switches after making an emergency radio (VHF) call for help. Fortunately, a fisherman heard our distress call and arrived in about

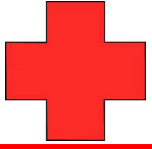
20 minutes. There was still smoke, but it seemed to be less than before.

I had no idea what happened in the engine room. Even though the engine has an overtemp and low water alarm, nothing had been triggered. I thought the halon engine room extinguisher might have functioned, but there was no way I was going to lift any hatches for at least 45 minutes. It never occurred to me that the extinguisher had already discharged, the engine ingested the halon gas, and that was the reason the RPM fell off. The Coast Guard from Fort Myers Beach arrived in about an hour, followed by Boat US Tow out of Marco. It was about a 3-hour tow back to Rose Marina; arrival was well after dark.

Blue Chip was trucked back to the boat yard on the Manatee River for repair. I was told the 'casting plug' (freeze plug) had fallen out of the bottom of the exhaust manifold dumping the fresh water coolant. The 900-degree exhaust gasses started the manifold paint on fire along with any surrounding combustible material. The whole event happened so fast that the alarms didn't have time to function. We were lucky! The fire had already burned away a small portion of the bridge deck insulation exposing the fiberglass and teak deck material.

The Yanmar diesel had to be removed from the boat, taken completely apart to clean the residue from the ingested halon, reassembled with a new exhaust manifold, turbo system, and after-cooler and finally put back into the boat. The engine itself was never overheated and even the cylinder sleeves were in perfect shape.

There are many procedures connected with boating that one can and should practice. You can't practice a real fire. United States Power Squadrons® education courses are the best way I know to help you make the right decision when faced with a dangerous boating situation. 🐟



Boaters, Check your First Aid Kit

After you prep your gear ... **AND** you have VHF (do radio check on ARCS via BoatUS or SeaTow—Marco area CH 27) EPIRB and-or SPOT/PFD's/safety equipment/cell phone aboard ... **AND** make sure someone knows your float plan. Prep your suggested medical gear (jumbo Ziploc bag is good) as follows:

Gauze pads, 2x2, 4x4, abd

Kerlix/kling

Bandage scissors

First aid tape/ace bandages/band-aids/duct tape

Steri strips

Towels/ponchos/blanket/travel umbrella (use as “shade”)

Big Ziplocs to discard contaminated stuff

Paper towels

Non latex gloves

CPR masks

Hand sanitizer, Betadine (alcohol is drying), bottled (drinking) water

Ice (better than commercial “ice packs,” if they leak, they can cause a chemical burn)

Liquid Benadryl (single dose vials)

Chewable baby aspirin

Only carry benadryl and aspirin if YOU are comfortable.

*****If you have a history of allergic reactions, please discuss with your Primary Physician whether or not you need to carry an “epi-pen,” (should have 2) since you are often away from land and easy access to the “EMS system.” ***If you use an epi-pen you still must get emergency medical care immediately!!!!**

Eye irritants

First aid booklet, Ex: ”Emergencies at Sea,” “First Aid Afloat”

Single-serving powder packets of lemonade/Gatorade/sugar, peanut butter or cheese crackers, trail mix, ginger or ginger ale. Water, water, water!!!

Sunscreen

Check and replace as needed every year.

After the pledge of allegiance and invocation, Cdr Gloodt, AP swore in the new members present and gave awards that were received at the D22 Spring Conference (p. 8-9). The luscious dinner of pork marsala or chicken by the Garza with trimmings were served. After dinner, the speakers were Dr. Roland Werres, a cardiologist and his wife Mary Werres, RN both with impressive credentials plus they have a background in sailing. Mary said the first thing to do is a VHF radio check when leaving the dock. Then she explained the items to add to a boater's first aid kit and their use (see p. 11). If a person needs CPR, drop anchor and tell someone (radio—they will ask 1) position, 2) # of people, & 3) problem). Don't run in, it will be too late; need to start CPR, time is important for brain tissue and heart muscle. After 4 minutes also necessary to breathe. Dr. Werres talked about what to do for fish hook injury, other injuries, marine poisons (stingray, lionfish, etc. clean & flush with hot water 115°), etc. also heat stroke (recognize & treatment) ... very informative. 🚤

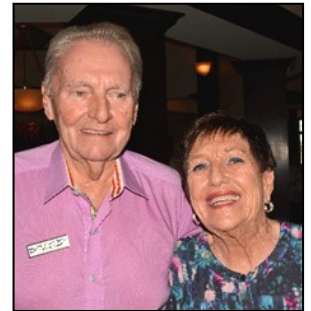

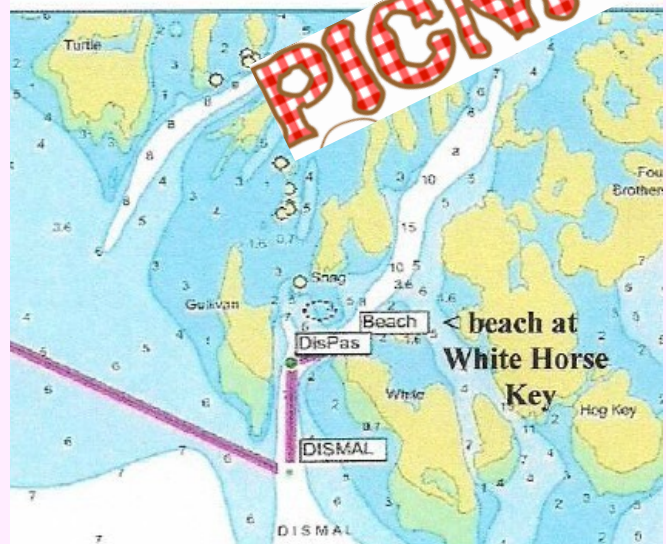

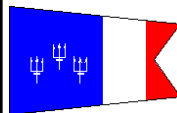

Over the last several weeks several MISPS COOP charting teams have expanded the waterways surveyed to identify missing or damaged aids to navigation.



On 14 April, the team of D/Lt/C Ted Reiss, SN-CN, P/C Peggy Reiss, JN-IN and P/C Carl Thieme, SN surveyed the ATON'S and PTON'S that start from Lighted Green Outer Marker #1 in the Gulf of Mexico and finish with Day Marker #55 on the Barron River in Everglades City. The team was pleased to report that all the Aids to Navigation were in good shape and located at the correct coordinates.

Three days later a second team including Lt Cliff Winings, SN, Lt Jim O'Connell, P, Jerry Williams, S and P/C Carl Thieme, SN surveyed the 40+ Aids to Navigation from the marina at Port of the Isles to the outer marker at Panther Key. A variety of issues were noted and will be reported to NOAA, the US Coast Guard and Collier County officials.

Meanwhile, Lt/C Gene Burson, AP and Lt Wanda Burson, S were busy surveying the area from the Judge Jolley Bridge leading into Addison Bay areas.

A 4th team of D/1/Lt Andy Battaglia, SN and Bryan Mordecai, AP was hard at work evaluating the condition of the ATON'S and PTON'S in the areas around Horr's Island, Kice Island, Helen Key and Cape Romano.

All the surveys were done on boats owned by squadron members. The dedication and persistence by the MISPS COOP Charting teams in conducting these surveys is starting to bear fruit with a number of new and repaired Aids to Navigation having been observed around Marco Island.

On 19 April, fourteen MISPS members took advantage of the CPR/AED/FIRST AID training session at the Marco Island Fire/Rescue station on San Marco Road. The instructor was Pat O’Gorman, Engineer, Paramedic, and Fire boat operator.

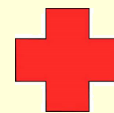
The purpose of CPR is to keep the brain and vital organs alive while waiting for rescue. The earlier CPR and AED are instituted the better the chances as there are 7-9 minutes worth of residual oxygen available to the vital organs after the heart stops. Chest compressions are the most important at 100-120 compressions per minute at a depth of two inches for an adult, one and a half for a child and infant. Rescue breathing is at a rate of 2 breaths after 30 compressions.

Squadron members practiced on both adult and infant dummies to the tune of “Staying Alive”. Teams of two traded off breathing and compressions on the adult. Instruction was given as to position of hands and technique on both adult and infant. In addition, there was instruction in using the AED for ventricular fibrillation.

Other topics in the training covered choking, scene safety, assessment and First Aid for the civilian. Paramedic O’Gorman spoke about fainting, cuts, bites, hypothermia, allergic reactions and many, many more situations.

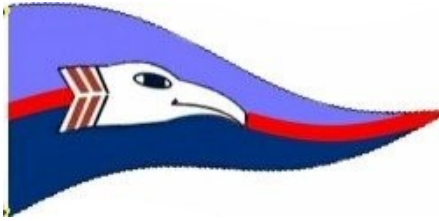
