Time to keep on learning. Boat Handling course starts on February 7th at 6 PM with ace instructor Nick Rago. This sevensession course was revised to incorporate the latest safety topics. Great information for new boaters

and a refresher for others.

America's Boating Course starting on February 13th is the first squadron course related to safety equipment, rules of the water-way, markers, lights, sounds, emergencies, docking, knots and lines. We even address rules unique to Florida waters.

Out next seminar is Partner in Command. We aim this at couples, one charge per couple. Are you the one who does everything or the one who may need to jump in and take over? #### USCG Fire Extinguisher Requirements

Now's the time to pay attention to a new federal regulation for fire extinguishers on motorized recreational boats that took effect on April 20, 2022. The big change

is that fire extinguishers older than 12 years from the manufacture date are no longer considered good and serviceable and should be replaced with a newer fire extinguisher.



This includes both disposable (non-rechargeable) and rechargeable fire extinguishers. And while you are checking your fire extinguishers, make sure they are properly pressurized, labeled for Marine use "Marine Type U.S.C.G." and are of the specific type required for your vessel length.

#### **Frequently Asked Questions – FAQs**

**Q1.** Where can I find the recently published regulations for fire protection for recreational vessels?

A. 33 CFR 175, Sub-Chapter S

Q2. What is the effective date of this new regulation?

A. April 20, 2022.

Q3. What is new?

A. If your fire extinguisher has a date of manufacture stamped on the bottle (example: "05" means 2005), and it is older than 12 years, the extinguisher is considered expired and must be removed from service. Look for wording on the bottle stating "This product must be removed from service within 12 years after date of manufacturing".

Q4. Are there any changes for when fire extinguishers are required or the number of extinguishers required?

A. No. If your boat was required to carry a fire extinguisher, it is still required to do so under this new regulation. There is also no change to the quantity required.

**Q5**. Which recreational boats are required to carry fire extinguishers?

- A. All recreational boats with: 1. Permanently installed fuel tank(s), or 2. Spaces that are capable of trapping fumes, such as a closed compartment under thwarts and seats wherein portable fuel tanks may be stored.
- B. Double bottom not sealed to the hull or that is not completely filled with flotation material.
- C. Closed living space.
- D. Closed stowage compartment in which combustible or flammable materials are stowed.

**Q6**. Are there any motorized recreational boats exempt from having to carry a fire extinguisher?

A. Yes. If your boat is less than 26' feet in length, uses an outboard engine, fuel is in a portable fuel tank, and there are no areas within the boat where fuel vapors can be trapped, the boat is not required to have a fire extinguisher.

**Q7**. How can I tell if a fire extinguisher is approved for my boat?

A. The label on the bottle will state "Marine Type – USCG Approved." Underwriters Labs approves fire extinguishers on behalf of the USCG.



**Q8**. How many USCG-approved fire extinguishers do I need to have readily accessible onboard my boat?

A. You are required to carry a quantity of 5-B or 20-B UL-rated USCG-approved extinguishers as required in the chart shown here for recreational boats 65 feet in length and less.

If your vessel is older than model year 2017, you may carry a B-I or B-II rated fire extinguisher instead, but you must replace them with a 5-B or 20-B when they are no longer good and serviceable.

All recreational vessels of model year 2018 and newer must carry 5-B or 20-B rated fire extinguishers that are date stamped. Vessels older than model year 2018 may carry either 5-B or 20-B rated fire extinguishers that are less the 12 years old or B-I or B-II rated fire extinguishers that are in good and serviceable condition.

Q9. How must my fire extinguishers be maintained?

A. Fire extinguishers must: 1. Be on board and readily accessible; 2. Be of an approved type; 3. Not be expired or appear to have been previously used; and 4. Be maintained in good and serviceable working condition, meaning: (i) If the extinguisher has a pressure gauge reading or indicator it must be in the operable range or position; (ii) The lock pin is firmly in place; (iii) The discharge nozzle is clean and free of obstruction; and (iv) The extinguisher does not show visible signs of significant corrosion or damage.

**Q10**. The gauge on my unused fire extinguisher is in the red. What should I do?

A. If a fire extinguisher pressure gauge shows that the charge is in the red zone, a disposable fire extinguisher must be discarded and replaced. A rechargeable extinguisher must be serviced and tagged. Suggested disposal sites include your local fire department.

**Q11**. What is the difference between a rechargeable and non-rechargeable portable fire extinguisher?

A. A non-rechargeable fire extinguisher, also referred to as a disposable fire extinguisher, is intended for one-time use only. A rechargeable fire extinguisher is recharged once used. A rechargeable portable fire extinguisher requires regular maintenance and servicing; a disposable does not. A disposable must be removed from service after 12 years from date of manufacturing stamped on the bottle. **Q12**. How do I tell if I need to replace my disposable (non-rechargeable) fire extinguisher if it is too old?

A. Disposable (non-rechargeable) dry chemical fire extinguishers, must be removed 12 years after their date of manufacture. These extinguishers generally have their year of manufacturing stamped on the bottom or have its year marked next to its UL label.

**Q13**: Where do I find the date of manufacturing on a rechargeable fire extinguisher?

A: The date of manufacturing on a rechargeable fire extinguisher is printed on the label of the bottle. The first National Fire Protection Association (NFPA) certified inspection is due one year from the date of manufacturing and the bottle tag must indicate this inspection. A rechargeable extinguisher does not need to be removed from service after 12 years, but it instead must be maintained annually by a technician.

Q14. I bought a fire extinguisher and in the box is a plastic mounting bracket. The label on the fire extinguisher bottle says it is valid only with bracket. Do I need to mount the fire extinguisher using this bracket?

A. It is highly recommended to mount the fire extinguisher, but it is not a requirement to mount the fire extinguisher. All portable extinguishers must be readily accessible.

#### Membership Corner P/C Peggy Reiss, JN-IN

Welcome to the Membership Corner!

## This month we feature members Shelly Derrough and Dave Randall.

A native of Springfield, Missouri Shelly attended Drury University for undergraduate studies and then the University of Missouri-Columbia for medical school on a Navy scholarship. Courtesy of the military, she has lived in Portsmouth, Virginia for obstetrics residency and then Naval Hospital Camp Lejeune, North Carolina. She practiced medicine in her hometown from 1999 until retirement in 2017. Shelly began boating at a young age on the Corps of Engineers Table Rock Lake, about one hour south of Springfield. Her family had a cabin where they spent most weekends during the summer. The family had deck and pontoon boats – a favorite on this lake. She still has family back in Springfield, where she and Dave spend summers as well as the annual frosty trip back home for Christmas. Shelly has completed the Power Squadron courses through Advanced Piloting and is presently enrolled in Junior Navigation under the tutelage of Tippy Cavanaugh.

Dave, a native of Grosse Ile, Michigan (an island where the Detroit River empties into Lake Erie) began boating with an aluminum skiff and a 1930's vintage Evinrude – the type with the built in gas tank and neither neutral nor reverse. Cruising grounds included the river and nearby Canadian waters. Water skiing was often accomplished in the southbound Livingston channel; it has break wall protection from waves but must be vacated for the episodic freighter! After attending Hope College, he studied medicine at the Uniformed Services University in the Navy. Subsequent training and duty stations included Naval hospitals in Portsmouth Virginia, San Diego, Millington Tennessee, and then Camp Lejeune, where he met Shelly. A two – year



stint was spent as the medical officer aboard the USS Raleigh (LPD-1). She carried Marines, landing craft, and helicopters. Cruising grounds included six weeks of and eight months for

training at Guantanamo Bay and eight months for

Desert Storm.

After the Navy, Dave practiced ear, nose, throat medicine in Springfield until retiring in 2018. He has had similar Power Squadron courses as Shelly, has his OUPV "six pack" license, and an International Certificate of Competence to bareboat in the Mediterranean.

Their first boat together was a 1985 Chris Craft



Catalina 381 on Table Rock Lake which afforded a perfect weekend getaway for two people, two cats, and the occasional guest. Their original plan was to cruise as sailors; they even did a very silly thing in purchasing and putting into charter service a sailing catamaran with two other couples from the Navy. They have had the opportunity to sail in the Chesapeake, Bahamas, Saint Martin, Grenada, Corsica, and Sardinia with family and friends. They



cut to the proverbial chase, however, and did what most sailors do eventually: move to a trawler. After dealing with

the usual plethora of maintenance issues and finding that she was too slow for their cruising needs, she was sold last year.

After a brief respite, they found a 1984 Hatteras 53 Extended Deckhouse and cruised her from Connecticut down to Marco over a couple of months. Never to be dissuaded by being, "vertically challenged," Shelly shows how she can improvise, adapt, and overcome when



needing to see over the dashboard and reach the overhead electronics! Cruising plans include

exploring the Gulf coast, a visit to the northern Bahamas, and perhaps (aboard a friend's sailboat) a summer cruise to Bermuda.

#### Marco Island Sail and Power Squadron Change of Watch, Jan 11, 2023

The Marco Island Sail & Power Squadron (MISPS), the local chapter of America's Boating Club, celebrated its 45th Change of Watch at a dinner meeting, Wednesday, January 11th at the Marco Island Yacht Club.

Outgoing Commander Wanda Burson introduced District 22 Commander Gene Burson who praised the squadron for its outstanding achievements in education and civic involvement. 
