BOSUN'S Whistle Bridge Report Cdr Chris Ricci, P Lt/C Christopher Frost, JN Lt/C James Addison, P







Recently the Ways and Means Committee, the Marketing and Communications Committee and the educational officers met to address two problems: 1) how to increase interest in our boating education classes (ABC courses) and seminars offered to the public and 2) how to increase participation in advanced classes — Seamanship (now called Boat Handling), Piloting (now called Marine Navigation), Advance Piloting, Junior Navigation and Navigation - as well as electives, seminars and on-water training offered to the membership. Addressing the latter is of concern to your bridge.

The severity of the problem is revealed if one looks at the membership information as reflected in the 2025 Fleet Roster. Out of 111 listed members, 52 (47%) have not taken any advanced courses or electives beyond ABC or have not participated in few, if any seminars. Twenty- two (20%) have taken Seamanship, 9 (8%) have passed Piloting and the same number for Advanced Piloting (8%). We have 10 Junior Navigators and 7 Senior Navigators (10 and 7% respectively). A Senior Navigator has competed JN and N and an additional 6 electives. Adding further evidence to the fact that many members have not availed themselves of advanced training, the courses recently offered in Marine Navigation, Marine Electrical Systems and Boat Handling either had few attending/completing the courses or classes that had to be canceled due to no interest shown. Seminars on Partner in Command, Charting/GPS, Anchoring, Hurricane Preparedness and Emergencies on the Water were offered this winter and were also canceled for the same reason.

While public boater education and safety instruction are important, as Past Commander, James E. Olmes SN observed in 2010, "we risk becoming as an organization, 'boating illiterate'" by not furthering our own boating education. Obviously, this concern

has arisen in the past and is still ongoing. He further commented that this situation seriously undermines and, maybe, compromises our mission as an organization and that "part of educational awareness comes from 'knowing what you don't know'".

Many of the members new to boating will find that advanced courses, electives and seminars will improve their knowledge so they can confidently navigate around Marco, lead cruises, use charts, dock confidently or perform other boating operations efficiently and effectively. For other members, a refresher course on what is new in boating or changes in the laws would be of benefit. It is a goal of the bridge to encourage members who haven't taken courses, electives or seminars to move up a notch to a higher level of knowledge.

Too many boaters rely heavily or exclusively on GPS or are not proficient at utilizing all its capabilities. We offer seminars presented in the classroom environment or on-line covering this and many other topics. In our Advance Piloting (now called Advanced Marine Navigation), Junior Navigation (now called Off-shore Navigation) and Navigation (now called Celestial Navigation) courses, one can learn alternative ways of navigating when GPS fails or is not available. Many of the techniques learned in these courses are applicable to our in-shore boating experience. In the Off-shore Navigation and Celestial Navigation courses, additional techniques are covered that are especially suited for those planning voyages away from the sight of land or finding one's location out in the ocean without the benefit of GPS.

In the near future, the bridge and educational officers will be asking the squadron to participate in a survey to ascertain what course, elective and seminar offerings would be of interest this coming fall and into next year. In addition, we would like to solicit your response and opinions on how, when or where they could be offered - whether in the classroom, on the water, dockside or combination of venues. There may be other boating topics of interest to our members. We are open to any suggestions and will arrange for instructors to teach any subject. There is so much more knowledge to be gained beyond what is taught in the basic boating course or even, in some cases, that learned from years of practical experience. Taking a course, elective or seminar can be a learning experience that is fun and challenging

- cementing friendships and adding a spark of competition at times. We encourage you to complete the survey, participate in the courses, electives and seminars offered and in turn, help further your boating knowledge.

DERELICT VESSELS

Any of you who have lived in the Marco Island, Goodland, and Naples area for any period of time, you have seen abandoned and, in many cases, sunken boats in our local waters.

Over the years I have always thought the best thing to do would be to tow all these boats offshore and sink them in one spot. That would make one heck of a fishing and SCUBA diving spot. Turns out that's not such a great idea. Thankfully our local and state law enforcement agencies have a solution to handle this problem. I have had conversations with people



who ask why
the process
takes so long.
As always, the
best thing to do
is to turn to
someone who
has the correct
answers.

Currently, as I

write this article, there is a sunken sailboat on the north side of the Marco River, across from Factory Bay.

I first reached out to Marco Island Police Department's Marine Patrol Officer, Josh Ferris, with some questions based on his experience,

1. From your experience what seems to be the most common reasons that these boats run aground and or get abandoned in the first place?

These derelicts can be caused by many different issues. Many of the boats that get abandoned are due to owners who don't have the physical ability to take care of the vessel or the time to dedicate to their commitment. Once the boats get run down and the owners can't keep them up, the boats often end up in an at-risk condition. At Risk indicates that the vessel is at risk of becoming derelict.

2. Why aren't the owners made to remove these boats?

The derelict vessel program is designed to hold the owners accountable, although it takes a lot of time to go through the notification and legal processes. Even when all these processes are effectively executed, if the owner doesn't have the financial means to pay for a salvage bill, then there's only so much that you can do to make the owner remove the boat.

3. If the owners don't get the boat removed, can't they be charged with a crime and forced to remove the boats? Does law enforcement have any recourse to force the owners to remove them or make the owners pay for the removal?

The owners can and will be charged with a criminal offense if they leave a derelict boat on state waters. Once again, there's only so much that can be done to force someone to remove a boat. There are grants available to find the money to pay for the removal of the vessels if the owners cannot pay for it. If the derelict vessel process is done correctly, these grants are available to municipalities, counties, and salvage companies. Once this is done, if the state chooses, they can go after the owners civilly.

4. It seems it takes a long time for the boats to get removed when the city, county, or state must get involved. Why is that. What are the steps law enforcement has to take to get the boat removed?

The fastest I've ever seen the derelict vessel removal process be completed is 6 months. This process consists of a notification and labeling of the vessel. This gives the owner a chance to correct the issue. Then, they can be issued a criminal violation that has to go through the district attorney's office and court system until it's completed.

After this process is done, if the owner is unable to remove the boat, the grant process must be completed correctly, which takes a while depending on a few different factors. Once the grant is awarded, then a salvage company has a period of time to affect the removal.

Folks must remember that the reason this process is so meticulous is because we are ultimately taking someone's property away from them and sometimes their home.

5. Where do these boats end up? Sold for parts? Landfills?

Once the salvage company removes the vessel, they can do what they want with it, but they normally end up in a landfill.

Okay, great information, but I thought I'd drill down a little deeper and check with FWC, our Florida Fish and Wildlife Commission, to see what they could add to the conversation. I reached out to one of our local FWC officers, Daniel Delgado, who introduced me to Arielle Callender the Public Information Director, South Region, of the Florida Fish and Wildlife Conservation Commission. Arielle told me about what the FWC does with derelict vessels and vessels that could soon be abandoned.

Derelict vessels are a top priority for the Florida Fish and Wildlife Conservation Commission (FWC). The Division of Law Enforcement's Boating and Waterways Section has led a multi-year effort to significantly reduce the backlog of these vessels waterways. across Florida's However, enforcement continues to document new cases, as derelict vessels persistently pose threats to the environment and public safety. Except for those affected by hurricanes or natural disasters, vessels do not become derelict overnight. Law enforcement officers identify warning signs that indicate a vessel is "at-risk" of becoming derelict. Through routine inspections, citations, and warnings, officers document vessel conditions and work with owners to bring their vessels into compliance before they reach a derelict state. FWC makes every effort to assist vessel owners in either removing their vessels from state waters or restoring them to a seaworthy minimizing taxpayers. condition. costs to Additionally, FWC collaborates with local governments through the Derelict Vessel Grant Program, which reimburses municipalities for 100% of the removal of eligible vessels once a grant agreement is executed. For cases outside this program, FWC also operates a Direct Removal Program, contracting directly with approved vendors to remove vessels.

The process of adjudicating and removing derelict vessels can be complex, often requiring multiple court hearings, orders, and administrative proceedings before removal is authorized. Vessel owners are afforded due process, including the opportunity for administrative hearings and potential criminal proceedings.

Once removed, derelict vessels are typically destroyed and sent to a landfill, though disposal methods may vary depending on the contractor and

county.

To proactively address the issue, FWC launched the Florida Vessel Turn-In Program (VTIP). This program allows eligible vessel owners to voluntarily surrender their at-risk vessels for removal at no cost. Owners who have received a citation or written warning for an at-risk vessel condition may apply if they meet the eligibility requirements. More details and applications are available at www.FloridaVTIP.com.

By addressing derelict vessels through prevention, enforcement, and removal efforts, FWC remains committed to protecting Florida's waterways, marine life, and the boating community.

Pretty interesting indeed. I did not know about the state's turn-in program VTIP, anyone who is aware of a possible boat that could be heading to a derelict condition needs to pass on the FloridaVTIP.com site if they can contact the owner.

Sadly, I am sure in our area of storms and other boat ownership issues, we will see sunken and abandoned
